

RTV SILENCE DETECTION End-User License Agreement

By installing this Software product, you agree to be bound by the terms of this EULA. If you do not agree with the terms of this EULA, please do not install this Software product or uninstall the software immediately.

DISCLAIMER OF WARRANTIES

The Software is supplied "AS IS". The Maker disclaims all warranties, expressed or implied, including, without limitation, the warranties of merchantability and of fitness for any purpose. The User must assume the entire risk of using the Software.

The Maker takes no liability for damages, direct or consequential, which may result from the use of the Software

TERMS

This agreement is effective until terminated. You may terminate it at any time by destroying the Software, together with all copies thereof. This License will also terminate if you fail to comply with any term or condition of this Agreement. Upon such termination, you agree to destroy the Software, together with all copies thereof.

The Maker always has the right to change the EULA. The Maker publishes the latest EULA on the web site.

The Software Product can be used in two different manners:

- As Trial Software (only for testing purpose)
- When you have a single User License.

As Trial (without a single or multiple User License) :

License grant

The Maker grants the User a non-exclusive license to test the Software with the built-in software restrictions. You may install and use the Software for evaluation purposes only.

Restrictions

The User MAY NOT:

- a) Redistribute, reproduce, copy or sell (a portion of) the Software
- b) Use the Software as portion of a product
- c) Alter, decompile, disassemble, debug, or in any way reverse the engineer of the Software
- d) Remove any copyright notices from the Software
- e) Copy the documentation.
- f) Use the Software always in production environments
- g) Deactivate the restrictions.

Users with a single user-license :

License Grant

The Maker grants the User a non-exclusive license to use the Software Product without restrictions. If you have purchased a Single User License, one copy of the Software may be installed and used on a single computer. The Software Product is in "use" on a single computer

when it has been loaded into the temporary memory ("RAM") or is installed on the hard disk or another device of that computer.

You may make a copy of the Software for archival purpose only or install the software on another computer if you change the workstation. Prior to this (if needed), you must uninstall the Software from the previous workstation.

Restrictions

You MAY NOT:

- a) Redistribute, reproduce, copy or sell (a portion of) the Software with the user-licensing file or user-licensing file only
- b) Use the software as portion of a product which is not made by the Maker
- c) Alter, decompile, disassemble, debug, or in any way reverse the engineer (?) of the software product
- d) Remove any copyright notices from the Software
- e) Copy the documentation accompanying the Software
- f) Sublicense, lease, rent or transfer the User License
